1. Key highlights of the 'Madhya Pradesh Udyogon Ki Sthapna Evam Parichalan Ka Saralakaran Adhiniyam, 2023'

The Act may also be called as	Madhya Pradesh Facilitation of Establishment and Operation of Industries Act, 2023
Objective of the Act	The objective of the Act is to provide exemption from obtaining specified approvals and their related inspections for establishing and operationalising an industrial units for a period of 3 years or before the commencement of commercial operation in the areas notified by the State.
Nodal Agency for Facilitation	MP Industrial Development Corporation Ltd. has been appointed as the Nodal Agency for the facilitation of Industrial Units under the Act
Applicability of the Act	The industrial units whose land is in the notified areas and have not commenced the commercial operation are eligible to avail the exemptions under the Act
Areas notified for the applicability of the Act	The applicability of the Act shall be for the areas notified by the State. Currently, 296 industrial areas of the have been included under the purview of the Adhiniyam. The list of the notified areas is available on the Invest Portal (https://invest.mp.gov.in)

Process to apply for the application for availing exemption under the Act	The Industrial unit can apply for exemption through the Invest Portal https://invest.mp.gov.in/ . <u>The unit will fill the "Intention to Invest for Acknowledgement Certificate' form, select the approvals for which exemption is solicited and submit the same for the approval of the department.</u> On the approval, an Acknowledgement Certificate will be issued to the Industrial Unit which will have the effect of an approval for a period of three years from the date of its issuance.
'Intention to Invest for Acknowledgement Certificate' Form	Intention to Invest is an electronic form available on https://invest.mp.gov.in/ , which would be filled by an investor. <u>The intention to invest contains the necessary information of an Industrial unit. Acknowledgement Certificate	Acknowledgement Certificate is a document issued to Industrial Unit which will provide exemption from obtaining specific approvals and related inspections for the period of three years or before the commencement of Commercial Operations
Inspections under the Act	Inspections shall be carried out only when the industrial unit applies for approval, prior to commencement of commercial operation or after the expiry of three years from the date of issuance of Acknowledgement Certificate

2. Frequently Asked Questions (FAQs) related to issuance of Acknowledgement Certificate under 'Madhya Pradesh Udyogon Ki Sthapna Evam Parichalan Ka Saralikaran Adhiniyam, 2023'

1. What is Madhya Pradesh Udyogon Ki Sthapna Evam Parichalan Ka Saralikaran Adhiniyam, 2023?

Ans: Madhya Pradesh Udyogon Ki Sthapna Evam Parichalan Ka Saralikaran Adhiniyam, 2023 has been published on 17 March 2023. The objective of the Adhiniyam is to provide exemption from obtaining specified approvals and their related inspections for establishing and operationalising an industrial units for a period of 3 years or before the commencement of commercial operation in the areas notified by the State.

2. Which are the notified areas where the 'Madhya Pradesh Udyogon Ki Sthapna Evam Parichalan Ka Saralikaran Adhiniyam, 2023' is applicable?

Ans: The applicability of the Adhiniyam shall be for the areas notified by the State. Currently, the following areas of the respective departments have been included under the purview of the Adhiniyam.

Note: The application submitted by the Industrial Unit for the respective industrial areas mentioned above would be approved by the Authorized Officers from the respective departments.

3. Which Industrial units are eligible to avail the exemptions under the Madhya Pradesh Udyogon Ki Sthapna Evam Parichalan Ka Saralikaran Adhiniyam, 2023?

Ans: The industrial units whose land is in the notified areas and have not commenced the commercial operation are eligible to avail the exemptions under the Madhya Pradesh Udyogon Ki Sthapna Evam Parichalan Ka Saralikaran Adhiniyam, 2023.

4. What are approvals for which the exemption will be provided to the Industrial Units under the Madhya Pradesh Udyogon Ki Sthapna Evam Parichalan Ka Saralakaran Adhiniyam, 2023?

Ans: Currently, 22 approvals and their related inspections pertaining to 7 departments have been included.

5. What is the process to apply for the application for availing exemption under the Madhya Pradesh Udyogon Ki Sthapna Evam Parichalan Ka SaralakaranAdhiniyam, 2023?

Ans: The Industrial unit can apply for exemption through the Invest Portal <https://invest.mp.gov.in/>. The unit will fill the "Intention to Invest" form, select the approvals for which exemption is solicited and submit the same for the approval of the department.

On the approval, an Acknowledgement Certificate will be issued to the Industrial Unit which will have the effect of an approval for a period of three years from the date of its issuance

The detailed process flow for the application of Acknowledgment Certificate is mentioned below:

Sr No.	Process Step Description
Step 1	The Industrial unit will log on to https://invest.mp.gov.in/ and will click on 'Intention to Invest' Tab
Step 2	The Industrial Unit will be redirected to the Registration window, where the user will enter details and will click on 'Register' button
Step 3	The Industrial unit will receive Login ID and password via SMS and Email
Step 4	The Unit will then click on 'Intention to Invest' button, page for Acknowledgement Certificate showing information can be view. The unit will then click on 'Yes' button the application will be initiated
Step 5	The unit will then select the 'District' and 'Industrial Area' from the dropdown and will click on 'Next' button
Step 6	The unit will then will the Intention to Invest form and will click on 'Next'
Step 7	The unit will then see the list of approvals from which, the unit can select the approvals for which the exemption is solicited
Step 8	The unit will digitally sign (Aadhar based) the application form and will submit the same to the respective department
Step 9	The respective department official will scrutinize the Intention to Invest application and will provide the decision within 7 working days. The department official will have the option to raise query to the industrial unit, in case any further clarity is needed. The department official will have the option to raise query to the industrial unit, in case any further clarity is needed. Note: If query is raised by the department, the unit will be intimated via SMS/ Email and once the query is responded by the unit, the respective departmental official will be intimated via SMS/Email as well.

Step 10	Once the approval is received from the Authorized Person, the Acknowledgment Certificate will be issued to the Industrial Unit which will be valid for a period of three years or before the commencement of commercial operation whichever is earlier. The status would be updated on the INVEST dashboard and the user will be intimated via SMS & email.
Step 11	As soon as the proposal is approved by the department, an intimation will be sent to the Competent Authorities of the respective departments for which the unit has applied for exemptions of the selected approvals.
Step 12	Once the application is approved, the unit can download the Acknowledgement Certificate from dashboard.

6. What is 'Intention to Invest' Form?

Ans: Intention to Invest is an electronic form available on invest.mp.gov.in, which would be filled by an investor. The intention to invest contains the necessary information of an Industrial unit. After the filing of Intention to Invest the Industrial unit may apply for the approvals for which it intends to avail exemptions for a period of 3 years.

7. What is Acknowledgement Certificate?

Ans: Acknowledgement Certificate is a document issued to Industrial Unit which will provide exemption from obtaining specific approvals and related inspections for the period of three years or before the commencement of Commercial Operations

8. What is the way forward after the submission of application for 'Acknowledgement Certificate'?

Ans: After the application has been submitted by the Industrial Unit, the application will proceed in the following manner:

- I. The decision on the submitted application will be taken within 07 working days
- II. The Authorized Officer from the respective department shall review the application and can raise query if required
- III. In case a query is raised, the unit may respond to the same through the dedicated dashboard avail in the Invest Portal
- IV. The unit will receive notifications via SMS and Email regarding the progress of the application
- V. If the application submitted is not acted upon within 7 working days, the application will be deemed approved

9. What is the timeline for the processing of the application for 'Acknowledgement Certificate'?

Ans: Once the application is submitted by the unit, the authorized official of the respective department is required to take the decision on the application received within 7 working days.

10. What if the unit wants to commence commercial production before the completion of 3 years?

Ans: If the unit intends to commence commercial prior before the completion of 3 years, they can proceed ahead by taking necessary approvals from the competent authority. All the units are required to have requisite approvals prior to starting commercial operations.

11. What are the Provisions of resolution of disputes between Competent Authority and Industrial unit?

Ans: State Level Empowered Committee (SLEC) has been constituted under the Adhinyam. The SLEC will facilitate amicable settlement of disputes between Competent Authority (department or agency) and Industrial unit for the approval

12. Will there be any inspections by concerned departments after receiving the acknowledgement certificate?

Ans: Respective departments / agencies may undertake inspection during the exemption period of 3 years in cases where there are complaints, or the company has applied for an approval and the inspections are required to be carried out by the competent authority. Detailed reasons/ justification along with the date of inspection to be provided by Department/Agencies.

13. What if any Industrial unit does not wish to apply for 'Acknowledgement Certificate'?

Ans: If any Industrial units who do not wish to apply for Acknowledgement Certificate for exemptions of approvals and their related inspections, shall be required to obtain necessary approvals as and when required without any delay.

14. Will the exemptions under the Act be applicable on the renewals of various approvals?

Ans: No. The exemptions from the renewal of approvals are not covered under the Act.

3. Initiatives taken by Department of Industrial Policy & Investment Promotion to enhance Ease of Doing Business

a. Exemptions to Industries for a period of three years

- I In lines with the announcement of the Honourable Chief Minister in GIS 2023 the State has published an Act called 'Madhya Pradesh Udyogon Ki Sthapna Evam Parichalan Ka Saralikaran Adhiniyam, 2023' on 06 April 2023
- II Salient Features of the Act
 - Exemption from obtaining specified approvals and their related inspections for a period of three years
 - Act applicable for 296 Industrial Areas notified by GoMP
 - Exemptions for 22 approvals and their related inspections pertaining to 7 departments
- III The module for application for exemption is available on the State's Single Window System
- IV More than 140 applications have been received under this initiative

b. Start your Business in 30 Days

- I To further improve and fast track the investments, an initiative called 'Start your Business in 30 Days' have been introduced by GoMP
- II The objective of the initiative was to reduce the timelines of licenses and approvals required for starting a business have been reduced to 30 days or less and introduce the provision of deemed approval wherever applicable
- III The salient features of the initiative
 - Timelines of 44 services pertaining to 8 departments have been reduced to 30 days or less.
 - Provision of deemed approval has been introduced for 35 services of 8 departments
 - More than 3.40 lakh applications have been disposed as per the reduced timelines
 - More than 17,000 applications have been deemed approved by the systems

c. Simplified Land Allotment System

- I The entire process of land allotment has been automated and provisions of deemed approvals have been introduced
- II The service delivery timeline for Land Allotment has been reduced from 59 days to 29 days

- III The portal provides the following salient features:
- Information related to land parcel including area of land, amenities, neighbouring units etc for making an informed decision
 - Real-time application status tracking, search facility on multiple parameters
 - Portal ensures time bound Land allotment process as per the provisions of PSG act.
 - The system is contactless and covers all the workflows related to land allotment
 - Auto Generation of Letter of Intent (LOI) for investments ≥ 10 Cr
 - Deemed Approval for LOI & LOA if not enacted by respective regional office within 7 days & 4 days respectively
- IV The service has been identified as one of the leading practices in the country by Government of India
- V Process is being automated for applications for availing undeveloped land in areas administered by MPIDC
- VI To further facilitate the investors, DIPIP & MPIDC have introduced provisions of availing plots in selected developed industrial areas of MPIDC on Equated Quarterly Instalments (EMI) with the discount of 5% to 20%
- VII Currently, such 25 industrial areas of all Regional Offices have been identified to provide land payment on Quarterly Instalment.

d. Automation of Incentive Module

- I Provisions have been made for online accepting and processing of applications related to Cabinet Committee on Investment Promotion (CCIP) & Investment Promotion Assistance (IPA)
- II The system provides the following salient features:
- Direct linkage with Intention to Invest module
 - Real-time application status tracking, search facility on multiple parameters
 - Digitally signed system generated documents
 - Linkage of CCIP application with Incentive Module, Claim Module, IPA
 - The system is contactless and covers all the workflows of the Incentive module

e. MP's Performance in GOI initiatives

f. Investor Facilitation

- c. Decriminalisation – Gwalior Vyapar Mela Pradikaran Act, to remove the penalty provision.
- d. Sub Registrar Power for signing execution of lease deed documents pertaining to Land Allotment in notified industrial areas
- e. DBT in self-employment schemes. End-to-end online application process right from submitting application to getting loan &subsidy
- f. Amendment in Land Rules 2021 and Start up Policy 2021 for giving priority and reservation to SC/ST entrepreneurs.
- g. GI-based mapping of available land areas to facilitate investors.
- h. Investor friendly exit policy for land management
- i. Onboarding MSMEs and State Department / Corporations / Local Bodies on TReDS platform to prevent delayed payments to MSMEs. Approval received from Government of Madhya Pradesh.
- j. Establishment of MP Startup Centre with a dedicated legal, finance and marketing expert to extend facilitation, hand holding support including financial assistance under the policy.
- k. MSEFC: Facilitate appeal cases through online proceeding; accepting virtual presence.
- l. Single profile creation for multiple services / application.
- m. Integration of MP Startup Portal with the Government of India's DPIIT portal and MP MSME portal for schemes like ZED etc.

5. Reducing Compliance Burden (RCB)

Government of India started an ambitious program on reducing compliance burden on businesses and citizens by making the regulatory framework simple & effective and thereby improving the competitiveness of Indian Economy.

DPIIT, GoI has been nominated as the nodal department for coordinating the entire exercise undertaken across all central ministries/departments and states/UTs to eliminate/reduce burdensome compliances, decriminalize laws and repeal redundant acts which have an adverse impact on time and cost of business/citizen related processes.

To systematically review regulatory compliances and monitor work done on reducing compliance burden, DPIIT has developed the Regulatory Compliance Portal (<https://eodbrcp.dpiit.gov.in/>) in which the States/UTs were required to enter the details related to burdensome compliances pertaining to respective departments.

The portal is monitored by the office of Cabinet Secretary, GoI to analyse the progress made by the States.

What is Burdensome Compliance?

The following are considered as the 'Burdensome Compliance'

1. Adds unnecessary procedure, time and/or cost for citizens/businesses and hinders overall ease of living or doing business
2. No longer protects safety nor public interest
3. Becomes no longer relevant (archaic/redundant) due to economic development and/or innovation in the market
4. Prescribes criminal provisions/imprisonment punishment for minor civil offences or where there is no mala fide intent.

Expectations from States under RCB

For successful completion of the exercise, the States are expected to:

- a. Eliminate or simplify unnecessary interfaces and complex procedures to improve Ease of Doing Business and Ease of Living

- b. **Make amendments to simplify, digitize and automate the process pertaining to the Acts/Rules/Regulations/Government Orders etc.** which cannot be repealed to facilitate in minimizing compliances for the end users
- c. Self-assess the procedures / rules / regulations / law/ acts / forms / information sought in the forms/number of documents to be attached/fees charged/issuance time for the services provided by the respective departments
- d. Evaluate the Acts/Rules/Regulations/Government Orders etc. and consider repealing them if they are outdated or redundant
- e. **Decriminalization and identification of provisions** of which prescribe **imprisonment as punishment for minor offences**
- f. Any other **initiative taken and implemented by the departments to reduce the compliance burden on citizens/businesses such as new online systems, simplification of process/procedure etc.**

Timeline for Reducing Compliance Burden (RCB)

Timelines for simplifying the identified compliance burden were divided into two phases with the end date of 15th August 2021 and 15th August 2022 respectively.

Performance of the State in Reducing Compliance Burden

The State has successfully completed the Reducing Compliance Burden exercise on 15th August 2022. The State reduced a total of 2427 compliances (Business – 813 & Citizens – 1614) pertaining to 39 departments.

The department wise compliances reduced for citizens and business

The 2427 compliances reduced by the State also includes repealing of 920 Acts which are redundant and are no longer in use such as The Hackney Carriage Act, 1879; The Stage-Carriages Act, 1861; The Improvements in Town Act, 1850 etc.

Focus on Decriminalization

Government of India has laid special emphasis on the identification of provisions under which criminal procedures and cases are registered against any firm/business.

The States are expected to identify such provisions and decriminalize them. The states are also required to upload the details of the same on the Regulatory Compliance Portal.

'Decriminalization' was one of the focus agendas for the first conference of Chief Secretaries held on 16-17 June 2022 at Dharamshala.

In this regard, CS review were held in the month of July 2022 to identify the provision of the Acts/Rules where the provision of decriminalization can be introduced.

During the reviews, a total of 114 Acts pertaining to 27 Departments were discussed. Out of these, 55 Acts were Centrally governed, and 59 Acts were governed by the State.

Under these 59 State Acts, there were 163 sections having criminal/penal provisions. Out of these 163 sections, there were 71 provisions where decriminalization is proposed by the respective departments.

Setting an example for all the States/UTs, DPIIT introduced the Jan Vishwas Bill (Amendments of Provisions) of Bill 2022 in Lok Sabha on 22nd December 2022. The Bill seeks to amend provisions across 42 Acts administered by 19 Central Ministries.

Current Status on Decriminalization of Acts/Rules in the State

As on date, the State has decriminalized various provisions under various State Acts such as:
