


**Amendment no 01**

With reference to the Selection of Empanelment Consultant Notice no. 01 and 02, following amendments are hereby made applicable:

1. The reply to Queries of Consultants is as attached in **Annexure A**.
2. The amended list of Projects for Notice no. MPIDC/CE/Select Empanel/2024/01 dated 20.06.2024 is hereby attached as **Annexure B**.
3. The date of submission of Presentation is hereby extended upto 12.07.2024. The date of Presentation will be intimated later.
4. It is also hereby clarified/amended that:
  - i. The selected consultant will be required to prepare the DPR with proper survey and investigation. In case of any deviation in the Project Cost during execution of the Project beyond 10%, penalty upto a sum of 10% of the consultancy fee shall be applicable on the consultant.
  - ii. The tentative costing of Rs. 1.00 Cr per hectare is only for the purpose of determining the eligible Category in which the consultant can participate. The payment of Fee shall be applicable on the actual DPR Cost after preparation. If required, the same may be adjusted on stage-wise payment.
  - iii. Agencies empaneled as on upto the date 10.07.2024 will be able to participate in the selection process.
